ARTICLE 1: NAME

The name of this corporation shall be, KENTUCKY ASSOCIATION OF USA TRACK & FIELD, INC.

ARTICLE 2: PURPOSE AND AUTHORITY

This not-for-profit corporation shall be the local governing body for the sport of Athletics in the Commonwealth of Kentucky and shall be responsible for and exercise all powers appropriate thereto, including the following:

1. Represent the Kentucky Association within the national governing body, USA TRACK & FIELD, INC.;
2. Administer the rules and regulations of the national governing body;
3. Develop interest and participation in Athletics throughout the Kentucky Association.
4. Serve as the coordinating body for all amateur athletic activity, including the conduct of championship events, in the sport of Athletics in the Kentucky Association area;
5. Keep amateur athletes active in Athletics informed of policy matters and reasonably reflect the views of such athletes in the policy decisions of the local and national governing body.

ARTICLE 3 GOVERNING BODY

The governing body of this corporation shall be the Board of Directors which shall be composed of the President, Vice-President, Treasurer, Secretary and the Chairpersons of each Sport and Administrative Committee. The Board shall be governed by the By-Laws of this corporation.

ARTICLE 4 FISCAL YEAR

The fiscal year of this corporation shall be from January 1 to December 31.
